STAFF RECOMMENDATION:

1. Adopt the proposed policy regarding the release of member, staff and trustee personal data.

### **DISCUSSION:**

MercedCERA often receives requests for data regarding members, staff and trustees. Generally, requests made through the Public Records Act are for member data regarding benefit amounts, cost of living increases and other 'public' information.

Information made of staff and trustees are often requested during the investment process by certain funds or general partners. MercedCERA has generally not complied with these requests on the advice from investment counsel.

In order to maintain consistency across all aspects of the organization, this policy is being proposed to assist with the transparency and consistency of data requests.

Staff recommends that the Board of Retirement adopts the proposed policy regarding the release of personal information of members, staff and trustees.



### Personal Information of Members, Staff, and Trustees

### **Purpose of this Policy:**

The purpose of this policy is to establish guidelines put in place by the Merced County Employees' Retirement Association ("MercedCERA" or "Association") regarding the protection and disclosure of personal information of Association members, trustees, and staff.

### **Objectives:**

- To maintain consistency in the disclosure of data requested from MercedCERA through public records requests, investments, and day-to-day business operations.
- Ensure that the personal information of Association members, trustees, and staff remain confidential to the extent allowed by law.

### **Governing Law:**

- Article XVI, §17 of the Constitution of the State of California vests the Board with "plenary authority and fiduciary responsibility for the investment of moneys and the administration of the system".
- Government Code section §31532 governs the confidentiality of members' records.
- California Public Records Act Government Code §6250, et seq.
- The Association is governed by the provisions of the County Employees' Retirement Law of 1937 (CERL), California Public Employees' Pension Reform Act of 2013 (PEPRA), as well as federal and state laws relating to public employees' retirement systems.
- California Government Code section §54950, et seq.

### **General Policy:**

## **Requests Under the Public Records Act (PRA)**

Under Government Code section 31532, the disclosure of member data is limited to the following:

- Name
- Retirement Benefit Amount (gross amount)
- Years of service (in aggregate)
- Last position held (cannot be verified by MercedCERA)
- Employer or Department retired from (cannot be verified by MercedCERA)
- Date of Retirement
- Cost of living adjustment
- Total health allowance

MercedCERA is only required to provide records which it prepared, owned, used or retained and does not have a duty to create a record when one does not exist (Government Code section 6252(e); *Haynie v. Superior Court* (2001) 26 Cal.4th 1061; 71 Ops. Cal. Atty. Gen. 235 (1998)). MercedCERA is entitled to charge a fee for the direct costs of duplicating any record. If a request is made for MercedCERA to construct a new record in electronic form, and the request would require data compilation, extraction, or programming, MercedCERA may charge for the actual cost

of constructing the new electronic record; including any costs of programming and computer services necessary to produce a copy of the record (Government Code section 6253.9(b)) and may extend the deadline to accommodate the request. As with any PRA Request, including any questions as to whether a public inquiry should be considered a PRA Request, any request that may involve "individual records" should be immediately referred to the General Counsel, who will determine how to respond in consultation with the Plan Administrator.

### Personal Information Requested During the Investment or Contracting Process

The MercedCERA Board of Retirement may enter into complex investment vehicles (or funds) that request or require the disclosure of trustee and staff personal information upon closing. Additionally, MercedCERA's consultants and contractors request the disclosure of trustee and staff personal information during the contracting process.

In response to the requests described above, MercedCERA's disclosures are limited to providing a trustee or staff's legal name and disclosing whether a trustee or staff member left their position with MercedCERA within the last three years.

### **Release of Information to Retired Employees of Merced County (REMCO)**

Upon retirement, retirees may sign up for REMCO membership and authorize MercedCERA to deduct REMCO membership fees from their retirement checks. If authorized on the REMCO membership application signed by a retiree, or authorized in another writing signed by a retiree, MercedCERA will release email and mailing addresses of retirees to REMCO to provide for REMCO's dissemination of newsletters and potential insurance offerings not affiliated with MercedCERA.

### **General Release of Information in Individual Records**

MercedCERA will not release information in a member's individual record to family (kin), labor unions, attorneys, or any other person or entity except upon receipt of a court order, or written authorization of the member or a person with power of attorney for the member. Any request for the disclosure of information MercedCERA receives that may involve a member's "individual record(s)" should be immediately referred to the General Counsel, who will determine how to respond in consultation with the Plan Administrator.

This Policy is adopted by the Merced County Employees' Retirement Association Board of Retirement on July 14, 2022.

### Discussion:

MercedCERA procured a new website in 2021 which is active and hosted at <u>www.MercedCERA.com</u>. Part of the new website project is/was to have professional portraits taken of our trustees and full-time staff. During 2021, professional portraits were put on hold.

The Plan Administrator is notifying the Board that staff will begin working with local professional photographer, Roger Wyan, to take a single pose portrait for website purposes. Each portrait would cost \$195 and includes professional photo retouching (skin smoothing, clean up of fly away hair, teeth whitening and eye whitening). MercedCERA would receive a one digital copy which would be used on our website.

The total anticipated cost for the portraits is estimated as follows:

Trustees: 11 portraits at \$195 =	\$2,145
Staff: 9 portraits (full time staff) at \$195 =	\$1,755
Total cost (without 8.25% tax)	\$3,900

Staff would be working with the photographer for appointments and/or a block of time for trustees and staff to have their portrait taken at the photographer's studio (due to lighting needs, etc.)

Because this expense was considered in the original scope of work for the MercedCERA website, this is a technology cost that is included in the non-administrative projection and the recently approved budget does not need to be amended.
